### **Sport Class Guidance - Brazil**

I hope this letter finds you well.

As you will be aware, IFCPF have worked to develop a new Classification Rulebook, in order to accomplish compliance with the IPC's Athletes Classification Code and International Standards. All the work done in the last four years has been used to develop the fairest possible classification system and classification procedures (i.e. evidence-based).

I would like to apologize for the slight delay in this communication, but IPC sent to IFCPF the feedback about the classification self-audit on December 14<sup>th</sup>, having January 12<sup>th</sup> as the deadline to respond to their requirements. In general, the evaluation was very positive, producing a new version of the CP Football Classification Rules and Regulations (attached to this communication).

As we communicated to you previously, the IFCPF Classification Committee worked with the observations of player's proficiency taking in mind the new Sport Classes, providing to our members a PROPOSAL (i.e. a Guidance) of the Sport Class that the players observed and/or classified in 2016 and 2017 could have with these new rules. You can find below the list of the observed players from your country:

You can see that some of your players had a “split” proposal (i.e. FT1/2, FT2/3, or FT3/NE). The observations were conducted by a minimum of four and a maximum of seven classifiers, including the IFCPF Head of Classification. In those cases where the consensus about the Sport Class was lower of 75%, we prefer to communicate to you that this/these athlete/s are a Borderline case. Thus, further classification/assessment will be necessary to take a final decision on him/them.

With the new Classification Rules and Regulations, all the players must undergo an Athlete Evaluation Session. However, we inform you that some players may be called for classification in 2019 in case: i) the observations and/or classification records from 2016/2017 are consistent with the proposed new Sport Class, or ii) the classification schedule in a particular competition is very constrained (i.e. number of New players, or number of “borderline” cases). It is the intention of IFCPF to classify all the CP Football players in the 2018-2019 period.
